### Terms and Conditions

#### Displaying the Permit

The customer is responsible for ensuring a valid parking permit is clearly displayed on the front windscreen above the tax disk on the passenger side, so that details are clearly visible from the front of the vehicle. Failure to display a valid permit will result in a parking charge notice. A valid permit allows the permit holder to park only in the car park that the permit was issued for. Parking in a car park with a permit for a different car park, and not displaying a valid ticket will result in a parking charge notice.

#### Losing your Permit

If you lose your permit/s a replacement will be provided at an administration cost of £20.00 each and your old permit will be cancelled and rendered invalid. This fee is non-negotiable and must be paid.

#### Validation of the Permit

Your permit will be rendered invalid if:

1. Payment has not been received by Holkham Enterprises
2. Alterations have been made to the permit
3. Your permit is not clearly displayed in the front windscreen above the tax disk on the passenger's side
4. Details of your vehicle have changed and you have not informed Holkham Enterprises in writing of these changes
5. The permit is not in date (your permit is valid from 1<sup>st</sup> January 2012 – 31<sup>st</sup> December 2012 inclusive)
6. A copy of the original permit is displayed – only the original permit is valid
7. The permit is faded (you must seek a replacement. A replacement will be free of charge in this instance).

As a result of presenting an invalid permit, and therefore breaching the Terms & Conditions of Contract Parking, a parking charge notice of £50 will be issued and may lead to Holkham taking action against the vehicle owner for fraud.

#### Space Allocation

A valid permit does not guarantee a space for the permit holder.

#### Large Vehicles

The parking of vehicles more than 2.00 metres high, 1.83 metres wide or 4.8 metres long requires the prior consent of Holkham.

#### Notes

1. Please make sure you supply a telephone number. This will only be used for contact purposes in the event we need to contact you concerning your vehicle.
2. Free admission to Holkham Hall excludes any special events unless specified otherwise.

Breaching the Holkham Estate's Terms and Conditions of Contract Parking will result in one or more of the following steps taken by Holkham Estate:

1. A parking charge notice is issued
2. Withdrawal of the parking permit and parking facilities
3. Issue of warning detailing the nature of breach.
